## **Course Description**

Located in Fontana, Wisconsin, Big Foot Country Club is a private member-owned golf and tennis club featuring a Tom Bendelow designed championship golf course routed over 270 acres of wooded land, rolling hills, and spring fed streams. The course features bent grass greens, tees, and fairways. A complete irrigation system and pump house was completed 4 years ago. The club has completed a master plan with Dave Zinkand and are looking to embark on several projects over the next couple years. Part of this would include an extensive bunker renovation, green and tee construction, native grassing, and fairway contouring and re-grassing to name a few.

## **Job Description**

The Assistant Superintendent will report directly to the Superintendent as well as the 1<sup>st</sup> Assistant Superintendent daily. This is a hands-on management position. The right person will be involved in all aspects of course maintenance including but not limited to employee management/training, chemical and fertilizer applications, irrigation repair, daily course set up, and watering playing surfaces and other golf course related tasks. This position is full-time with an expected work week consisting of 46-50 hours. Creative management by the supervisors allows for time off on weekends and sometimes weekdays. As the club works towards potential projects, this candidate will be an integral part of the development and institution of this plan.
